Listed below are details of the standard presentations we have prepared:

❖ Home Inspections – A General Introduction

Presents a brief overview of why home inspections came about, their purpose, their scope, and some of the common issues encountered during home inspections. This presentation will also summarize the current California State laws as they relate to the home inspection profession, how to select a home inspector, and how to interpret the results of your inspection.

❖ Common Home Inspection Issues

An entertaining and informative presentation which walks you sequentially through the major systems which are inspected during a typical home inspection. Photographs from actual home inspections are used to illustrate commonly discovered issues.

❖ The Benefits of a Listing Inspection

Listing inspections are becoming increasingly popular as a tool for sellers to learn more about the condition of their properties prior to listing. This presentation explains the benefits of these inspections, how they can help with seller's disclosures, and how they can act as a marketing tool for the Realtor.

❖ CREIA Standards of Practice – An Overview

The California Real Estate Inspection Association (CREIA) publishes standards of practice (SOPs) to define the minimum requirements for a home inspection. This presentation provides an overview and history of the SOPs, and discusses their relevance and importance in the home inspection process.

❖ Water Heaters

Water heaters are often installed incorrectly and without the proper permits. This presentation explains how to spot common water heater issues, and the significance of the issues. Improperly installed water heaters can present a major safety hazard, but most issues are readily fixable.

❖ Electrical Systems

Electrical systems issues are common, especially in older and/or remodeled homes. This presentation will highlight some of the common issues, as well as commonly recommended upgrades and their safety benefits.

❖ Plumbing Systems

Water damage is one of the biggest sources of insurance claims and interior damage. Leaks in water and drain pipes are common, but there are also other common problems with venting, trapping, and cross-connections that can have occupant health implications. This presentation will point out some of the common issues, and how to recognize them.

❖ Mechanical Systems (Heating & Cooling)

Often improperly installed and installed without permits, issues with heating and cooling systems are common. Heating systems are often gas fired, and improper installation has the potential to cause carbon monoxide poisoning. This presentation includes common installation photographs to help you recognize and understand these issues.

❖ Foundations

Whether slab-on-grade on expansive soils, or raised foundations in older homes, the foundation is the most important structural element of the home. Often older homes do not have sufficient seismic bolting and bracing, and may have cracks in the foundations or water intrusion into crawl spaces. This presentation includes photographs of commonly found conditions and explains the importance and significance of proper seismic upgrading to protect your client's investment.
